#### SPECIAL MEETING MINUTES

- Date: March 23, 2023
- Time: 1:00-5:00 p.m.

Call to order - President Langland called the special strategic planning retreat to order at 1:05 p.m.

- 1. **Approve/Amend March 23, 2023, Retreat Agenda -** Commissioner Noble moved to approve the agenda, which was seconded by Commissioner Pryne, and approved unanimously.
- 2. **Vision Statement Development -** Mr. Kunkel provided an overview of the retreat agenda, commencing with the Vision Statement Development:
  - **a. Presentation of individual statements** Commissioners all shared their respective individual vision statements and the group explored key intentions and phrases:
  - **b.** Key word/phrase alignment Key ideas and common themes from the statements were captured and explored by the group such as:
    - accessibility and access; and components of access: affordability, presence, etc.)
    - primary care vs health care
    - measureable & data
    - accountability
    - improve (too incremental?),
    - "island-based" and "island-appropriate"
    - "support" funding, provision of resources, services
    - *"equity" (in terms of access)*
    - "wellness"
    - partnership & collaboration
    - education/public awareness
    - ideal vision vs vision based on constraints
    - stewardship of public and private

#### 3. Criteria, Weighting & Implementation of Opportunities

a. Listing of potential criteria - Commissioners created a list of potential criteria for assessing options and conducted a ranking exercise, resulting in the following priorities:

- Primary Care (53)
- Collaboration (38.5)
- Stewardship (37)
- Equity (35)
- Communications (21.5)
- Advocacy (20)
- Education (17)
- Innovation (14)
- Social Determinants of Health (14)
- Expanded Healthcare (4)
- b. **Implementation**: Commissioners had a preliminary discussion on implementation on the following topics:
  - i. Annual Cycle v. "as they come" & One-time v. Ongoing Commitments -Commissioner Pryne expressed that some things are ongoing and need continuous support and raised the question of whether we are open to multiple year commitments or only single year and also, if we are a donor, we need to determine if there are multiple rounds per year; Commissioner Wolczko expressed a need to maintain flexibility for one-offs that might arrive such as the AED effort earlier this year; Commissioner Aman advocated for all expenses to be cycled through the agreed upon criteria and also pointed out that it is best for decision-making to assess possibilities in 'a batch'.
  - **ii.** Set Aside for primary care 'safety net' general agreement that funds be reserved as a safety net in the event that a primary care subsidy is necessary.
- 2. **Strategic Structure Moving Forward** As time expired, Mr. Kunkel shared some of the plan for developing the vision and strategic plan moving forward. The next follow-up session will be held as part of the regular meeting on April 5th and as an agenda item on regular meetings going forward.
